Material Changes

Stock Split

On July 31, 2026, the Board of Trustees approved a 1-for-10 reverse stock split for the Fund. The reverse stock split was effectuated after the close of trading on August 21, 2026, and the shares of the Fund began trading on a split-adjusted basis on August 24, 2026. The Creation Unit size remained at 5,000 shares per unit.
